## **Recommendation**

Development Services staff requests that the Board of Supervisors take the following Action:

1. Approve the one (1) additional appointment, Donna Bayles, to the Citizens Advisory Committee pursuant to the recommendations of the Board's General Plan Ad-Hoc Committee and as shown on the Official Roster of the Citizens Advisory Committee, and remove April D. Grossberger from the Official Roster of the Citizens Advisory Committee due to her appointment to the Town of Paradise Planning Commission.
2. Approve the attached Updated Citizens Advisory Committee Resolution.

## **Summary**

An additional applicant, Donna Bayles, is recommended to serve on the Citizens Advisory Committee by the Board of Supervisors Ad-Hoc General Plan Subcommittee. This new applicant will bring the total number of people serving on the Committee to 35. Additionally, an

amended Resolution has been provided that updates the previous resolution (Resolution 06-133) to show a total membership of 35. Existing Citizens Advisory Committee member April D. Grossberger has been appointed to the Town of Paradise Planning Commission. For this reason staff, recommends the removal of Ms. Grossberger from the Citizens Advisory Committee. This will create an additional vacancy on the Citizens Advisory Committee. Staff will work with the Board of Supervisors General Plan 2030 Subcommittee on finding a suitable replacement within the next several weeks.

### **Background**

The Board's Ad-Hoc General Plan Subcommittee reviewed an additional application on April 26, 2007 and recommends the appointment of this applicant to serve on the Citizens Advisory Committee (Attachment A). The subcommittee felt that additional representation was needed for the Gridley/Biggs area and that the applicant was qualified to serve on the Citizens Advisory Committee.

The previous Resolution establishing the method for appointment of members and the Work Program for the Citizens Advisory Committee has been updated to reflect the total number of members (35) serving on the Committee.
