

POLICY ALTERNATIVES

This document includes policy ideas that have been developed throughout the General Plan 2030 process. The initial policy alternatives document was approved by the Board of Supervisors on November 27, 2007, during the final meeting of the Alternatives Finalization phase (Meeting Series #2/3). These policy alternatives were intended to establish a framework for the Goals and Policies Development phase of Butte County General Plan 2030 (Meeting Series #5).

This version of the policy alternatives document includes input from the public, Citizens Advisory Committee (CAC) and Planning Commission that was received during Meeting Series #5, as well as the final direction from the Board of Supervisors that was provided on February 18 and 19, 2009.

Urban Growth Boundaries and Community Separators

1. **Should the County implement additional urban growth boundaries, and if so, how?**
 - a. Engage unincorporated communities who want to do so, in a community planning process, as resources are available, to set a community vision, with the possibility of developing urban growth boundaries as part of that process.
 - b. Work cooperatively with municipalities to establish urban growth boundaries and revenue sharing.

2. **Should Gridley and Biggs have a community separator between them?**
 - a. No comment on this topic; let [the municipalities](#) work out through resolution to Question 1.

3. **How should the public be involved in setting urban growth boundaries?**
 - a. Do not change the existing process to establish urban growth boundaries. However, it should be noted that the public must be involved in that process.

4. **What modifications, if any, should be made to the Chico Area Greenline, which establishes a boundary between urban and agricultural uses in the area west of Chico?**
 - a. [Do not change the Chico Area Greenline.](#)
 - b. [Engage in a collaborative community-level planning process with the City of Chico in the Bell Muir area, as needed.](#)

[Note: During the Selection of a Preferred Alternative phase, the Chico Area Greenline had been modified to include the majority of the Bell Muir Study Area on the urban side of the Greenline. This is reflected on the Draft General Plan land use map.](#)

~~Note: The CAC did not make a recommendation on this question. The majority of the Planning Commission recommended that the Board of Supervisors modify the Greenline to follow the northwest boundary of Study Area 3 (Bell Muir).~~

5. How should the County protect the Neal Road Landfill?

- a. Establish a compatibility zone of appropriate width around the landfill that allows uses that are compatible. Compatible uses include the following: uses that do not involve on-going occupation by people (e.g., residential uses); uses that are not bothered by the visual, noise, odor, such as agriculture, light industrial and traffic issues associated with the landfill; and uses that people don't want elsewhere (i.e., uses with their own visual, noise, odor and traffic issues). The compatibility zone will be preliminarily mapped at 2,000 feet around the landfill, sewage treatment plants.

County Character, New Development and Housing

6. How should the County improve the design and architectural quality of new development?

- a. The County should not establish aesthetic design regulations for any uses or specific areas except within municipalities'~~cities'~~ spheres of influence, where the County should adopt the design regulations of the respective municipalities~~cities~~, but only with respect to nondiscretionary criteria that would not require review by a design review board.
- b. Establish limits on ridgeline~~Avoid~~ development in order to minimize visual impacts. Development guidelines will address the following: building footprint, color (i.e., structure should blend in); setback from edge of ridgeline; vegetative screening; height of structures; fencing; and light pollution. Development standards will allow exceptions if there are no other options on a parcel.~~on ridgelines.~~

7. How should the County work to provide more affordable housing? (For the purposes of the General Plan, “affordable housing” is defined as housing that is affordable for “very-low” and “low” income households, which are households that earn no more than 50% and 80% of the County’s median income, respectively. “Affordable housing” does not cost more than 30 percent of a household’s income.)

Note: the Planning Commission and Board of Supervisors recommended that this question be deferred to the Housing Element Update, which is also underway, and will have its own meeting series.

Regional and Local Coordination

8. How should the County more effectively coordinate its planning efforts with those of the five incorporated municipalities, other Counties, ~~and~~ other planning and regulatory agencies?, ~~and local Native American tribes?~~
- a. Hold ~~annual~~quarterly or more frequent staff level or decision-maker subcommittee meetings with each of the municipalities to discuss planning and land use issues of concern, and publish an annual report of the findings of those meetings.
 - b. Hold public meetings with each of the municipalities to discuss planning and land use issues of concern, and air recordings of these meetings on public access television.
 - c. Work with the Local Agency Formation Commission (LAFCO) to develop a coordinated, countywide growth and annexation strategy.
 - d. Negotiate revenue sharing agreements with the ~~municipalities~~cities to ensure that if ~~municipalities~~cities annex unincorporated areas, the County will have access to adequate revenues to maintain countywide services that benefit residents of both the County and the ~~municipalities~~cities.
 - e. Cooperate to create a broader regional planning authority covering Butte County and its neighboring counties, and identify strategies for coordinated planning in the region.
 - f. Collaborate on planning and building within the municipalities' Spheres of Influence, so that development standards are essentially the same regardless of whether development occurs under municipal or County jurisdiction. The County has already been collaborating with municipalities on development standards, and will continue this collaboration.
 - g. Continue to work with the five municipalities ~~Work with the Butte County Association of Governments~~ to coordinate development and conservation activities with the Butte Regional Conservation Plan (HCP/NCCP) being developed under the

auspices of the Butte County Association of Governments (BCAG).

- h. Coordinate planning efforts with those of special districts and school districts.

9. How should the County work with local unincorporated communities in planning for their futures?

- a. Support planning efforts in unincorporated communities.
- b. Provide staff support for such community planning efforts as available. ~~recent efforts in Berry Creek, Forest Ranch, Cohasset, and others.~~
- ~~b. Provide staff support for such community planning efforts.~~
- c. Fund the creation of Area Plans (similar to the Durham Dayton Nelson Plan) in communities that request such planning, provided that funding is available.
- ~~d. Create a dialog with local Native American tribes for collaboration on tribal land use plans.~~

Agriculture

10. What, if any, modifications are needed to General Plan Program 2.2 (the Agricultural Buffers policy, which requires a buffer to be established on property proposed for residential development in order to protect, maintain, promote and enhance agricultural uses and resources)?
 - a. ~~Maintain~~~~The General Plan should defer to~~ the Agricultural Buffers Policy~~buffer modifications currently being developed and reviewed as part of the~~ Agricultural Buffer -Guidelines.
 - b. Continue to encourage defensible buffers.

11. How should the County help to protect, maintain, promote and enhance its agricultural uses and resources?
 - a. ~~If approached by a municipality, the County would work~~~~Work~~ with municipalities and regional agencies to consider developing ~~develop~~ a transfer of development ~~rights-credits~~ program that would allow agricultural landowners to sell ~~the rights~~credits to develop their land to urban landowners, who would get ~~the right~~credit to develop their properties at higher densities than normally allowed under base zoning.
 - b. Work with State and federal agencies to provide and maintain transportation infrastructure to get goods to markets and ports.
 - c. Work with water agencies and irrigation districts to improve the distribution of water for agricultural uses.
 - d. Continue to work with landowners in establishing new and maintaining existing Williamson Act contracts.
 - e. ~~Develop a plan to support farmworkers, addressing issues such as housing, medical care, education, childcare and pesticide exposure.~~
 - e. Encourage provision of housing for agricultural employees.
 - f. Ensure sustainable agriculture by encouraging agricultural users to conserve water, plant drought-tolerant crops, and protect natural resources.

- g. Support agricultural education and research at Butte County educational institutions.

~~Note: The CAC applied the following policies from a presentation provided by Jamison Watts of the Northern California Regional Land Trust. The policies were part of the Stanislaus County General Plan. Policies pertaining to ranchettes came from Mike Darnell, American Farmland Trust. The Planning Commission revised these policies in consideration of suggested revisions by DC&E in order to tailor them to Butte County and reflect existing County policies and programs.~~

~~i. The Board of Supervisors should consider including the following policies in the General Plan:~~

~~i. Create an agricultural mitigation ordinance in which developers will be required to permanently protect agricultural land in place of land that is proposed for conversion from agricultural to non-agricultural use. This ordinance may include the option of paying an in-lieu fee that would contribute to an agricultural resource protection fund. The ordinance will establish mitigation standards that address the valuation and geographic location of agricultural land.~~

~~ii. Continue the existing Policy 2.7 and Program 2.7 of the Agriculture Element, and eliminate 5-acre lot allowances in agricultural designations. However, if 5-acre lots are continued in agricultural designations, the following policies should be included:~~

- ~~▪ Allow subdivision of new 5-acre agricultural parcels only where they will be used for specialty and/or unique crops in transition areas between agricultural and urban uses.~~
- ~~▪ Develop stricter site design standards for development on agricultural parcels, to allow for the continuation of viable agricultural uses.~~

- ~~▪ Require the preparation of an Agricultural Production and Stewardship Plan for new residential development on agricultural parcels. The Plan would demonstrate how the property would be kept in agricultural use, and would be reviewed and approved by the Butte County Agriculture Commissioner.~~
- ~~▪ Allow agricultural support uses, such as processing facilities or outbuildings, on small parcels that are designated for agricultural uses if those parcels are no longer viable for active cultivation.~~
- ~~iii. Establish minimum allowable parcel sizes agriculturally designated lands that do not promote the expansion of existing, or creation of new ranchette areas.~~
- ~~i. Encourage municipalities in Butte County to adopt similar agricultural mitigation ordinances, in which developers would be required to permanently protect 1 acre of agricultural land in Butte County for every 1 acre of land that is proposed for re-designation from agricultural to residential use, or pay an in-lieu fee that would fund agricultural resource protection.~~

12. How should the County help to protect, maintain, promote and enhance its timber uses and resources?

- a. Encourage regulations and outreach practices that would provide for sustainable forest practices in the county. Support and cooperate with CAL FIRE in their responsibilities related to timber and forest practice laws.~~County.~~
- b. The County should maintain and amend where appropriate existing requirements under the Timber Preserve Zone to conserve and enhance its timber resources, protect water quality and conservation, and improve fire safety. Work cooperatively with CAL FIRE and the State's timber resources laws and statutes.

- c. Implement community wildfire protection plans and wildfire fuel load measures in coordination with the appropriate government/citizen agency and CAL FIRE~~Butte County Fire Safe Council.~~

13. How should the county address the conversion of smaller agricultural parcels to non-agricultural uses?

Note: this issue has been addressed by increasing the minimum parcel sizes in agricultural areas. Specifically, minimum parcel sizes in the Orchard and Field Crops designation have increased from 5 to 40 acres and in the Grazing and Open Land designation from 40 to 160 acres. These designations will include the ability for the Board of Supervisors to allow exceptions to the minimum parcel sizes under certain circumstances. Additional criteria will be reviewed by the Board of Supervisors for determining how exceptions would be granted in instances where agricultural viability is called into question. This will be reviewed during the Draft General Plan/Zoning Ordinance meeting series.

~~Rather than providing specific policies other than as noted below, the Planning Commission provides the following direction to the Board of Supervisors in creating agricultural land use designations in the Land Use Element and Map: Increase minimum lot sizes of the agricultural land use designations to reflect the viability (e.g., 40 acres for cropland, 160 acres for rangeland).~~

~~a. In areas where conversion of small parcels to non-agricultural use is discouraged:~~

~~i. Require a conditional use permit for residential uses in agricultural zones.~~

14. How should the County encourage and enhance niche and small-scale specialty agriculture, ~~such as organic products, heritage livestock, heirloom crops and native plant nurseries?~~

- a. Facilitate the establishment of specialty farming areas that grow higher value crops.
- b. Encourage the establishment of small-scale agriculture uses such as specialty crops, organic farming, specialized animal facilities, and agricultural research operations on small parcels of land in existing agricultural areas.
- c. Recognize the role of smaller farms growing specialty products in Butte County. A unique land use and/or zoning designation may be applied to specialty farming areas to recognize the needs of smaller farms, specialty farms, and part-time farmers.
- d. Support agritourism uses such as farmstays, education and local retail sales in the Zoning Ordinance.
- e. Support farmers in diversifying their products ~~to produce and market healthful foods, specialty ethnic foods, and foods needed and desired by local consumers.~~
- f. Allow unique zoning to encourage and enhance specialty agriculture.
- g. Consider impacts to the traditional Native American landscape when developing additional land, including when developing land for agriculture.

15. The Board of Supervisors recently approved changes to the Right to Farm Ordinance to address conflicts between agricultural and non-agriculture land uses. What other strategies should be pursued to address these conflicts, if any?

Note: The CAC, ~~and~~ Planning Commission and Board of Supervisors concluded that no additional strategies are needed.

16. What strategies should the County use to support the local agricultural economic sector?

- a. ~~Support~~Develop a Community Supported Agriculture (CSA) program if one is developed. (Community Supported Agriculture consists of a community of individuals who pledge support to a farm operation so that the farmland becomes, either

- legally or cooperatively, the community's farm, with the growers and consumers providing mutual support and sharing the risks and benefits of food production. Typically, members or “share-holders” of the farm or garden pledge in advance to cover the anticipated costs of the farm operation and farmer's salary.)
- b. Support the development of an agricultural marketing and tourism program to coordinate private and public initiatives and to integrate them with County business attraction efforts.
 - c. Consider providing a regionally focused agricultural center or business park.
 - d. Develop a marketing plan to promote agricultural products that are grown in Butte County and develop a “brand recognition” for these products.
 - e. Promote agritourism, such as through special events and themed “farm trails” and routes within Butte County’s agricultural areas.
 - f. Establish agricultural business and agricultural manufacturing zoning districts that allow retail and industrial uses that support agriculture.
 - g. Encourage development of food processing and other facilities that could support production of “value-added” farm products from Butte County.
 - h. Support existing grower cooperatives in Butte County.

Water Resources

17. How should the General Plan protect and enhance Butte County's water supply?

- a. Support Area of Origin water rights, the existing water right priority system and the authority to make water management decisions locally to meet our current and future needs thereby protecting Butte County's communities, economy and environment.
- b. Implement and periodically update an Integrated Water Resource Management Plan ~~integrated water resource management plan~~ to ensure the sustainability of water resources for the county.
- c. Continue the Four-County Memorandum of Understanding (MOU) with Colusa, Glenn and Tehama counties, and continue to foster regional cooperation ~~operate~~ with other ~~adjacent~~ counties and water districts to plan for and manage water resources in a way that includes sound science and public participation.
- d. Ensure that new development can demonstrate an adequate water supply including an evaluation of potential impacts to surrounding groundwater users and the environment.
- e. Promote agricultural and urban water use efficiency to advance sustainability of water resources.
- f. Require new development to adopt best management practices for water use efficiency.
- g. Seek to fully ~~Fully~~ utilize the County's State Water Project Table A Allocation within Butte County, including consideration of options to transport Feather River water.
- h. Continue to utilize the Butte County Water Commission and the Department of Water and Resource Conservation as an important part of the water resource planning process.
- i. Support solutions to ensure the sustainability of community water demands.

- j. Establish programs to protect and promote groundwater recharge.
- k. ~~Seek funds and develop~~ **Develop** programs that improve the scientific understanding of our aquifer systems, and potential factors related to the sustainability of our water resources.
- l. ~~Continue to regulate~~ **Regulate** groundwater transfers and substitution programs in order to protect the sustainability of the County's economy, communities and ecosystem.
- m. ~~Continue to ensure~~ **Ensure** the sustainability of groundwater resources (groundwater levels, groundwater quality and avoidance of land subsidence) through a basin management objective program that relies on management at the local level, utilizes sound scientific data and assures compliance.
- ~~n. Seek funding for and conduct~~ **Support efforts to transport Feather River water from Lake Oroville to the Paradise and Chico areas.**
- ~~o. The following programs should be included in order to implement the policies above:~~
 - i. ~~Conduct~~ comprehensive, county-wide mapping of ~~ground~~water resources.
 - ii. ~~Seek funding for and conduct~~ **Conduct** comprehensive mapping of groundwater recharge areas.
 - iii. ~~Seek funding for and conduct~~ **Conduct** scientific analysis of the costs and water supply impacts of groundwater pumping.
 - ~~iv. Protect groundwater recharge through the establishment of Recharge Zones in which development will be limited and historical groundwater recharge rates will be monitored. ensured.~~
 - ~~v. Strengthen the ordinance that governs groundwater transfer (Chapter 33) to require an independent analysis of potential third party impact, require full mitigation for third party~~

~~impact, and require approval by the Board of Supervisors rather than the Water Commission.~~

- ~~vi. Establish a program to capture runoff water.~~
- iv. ~~Within the Basin Management Objective process governed by Chapter 33, establish provisions for mandatory corrective or mitigation measures when groundwater levels decrease to a dangerous threshold.~~

Note: The Policy Alternatives document had originally asked for strengthening the Butte County Ordinance that governs groundwater transfer (Chapter 33) and changes to the Basin Management Objective process (governed by Chapter 33 (a)). The Board directed that changes to Chapter 33 and 33A be pursued separately from the Butte County General Plan 2030 Goals and Policies process and that these changes would be discussed as a stand-alone agenda item at the Board. This item would be handled by the Department of Water & Resource Conservation.

18. How should the General Plan seek to maintain and enhance Butte County's water quality?

- a. Develop water quality protection policies based on strategies to preserve and restore natural infrastructure, reduce runoff, and encourage more efficient use of water supplies. These include, but are not limited to:
 - i. Expand monitoring and reporting efforts of Butte County's Department of Water and Resource Conservation.
 - ii. Promote low impact development that ~~is high density,~~ has low amounts of impervious area, and incorporates best management practices.
 - iii. Educate the public to limit~~Limit~~ pollution from pesticides and nutrients in urban~~through incentives~~ and domestic settings~~regulations related to stream buffers~~.
 - iv. Maintain existing regulations that protect water quality from agricultural uses.

- v. Establish grading and construction regulations to minimize erosion and urban stormwater runoff.
 - vi. Promote the recharge of wetland areas.
 - vii. Develop domestic well standards and programs to ensure that groundwater resources are protected, including a requirement for water quality testing with the drilling of new domestic wells.
 - viii. Support establishment of a system for proper disposal ~~of pharmacies to accept~~ expired medications ~~for proper disposal~~.
 - ix. Design new developments to minimize runoff and pollution.
 - ~~x. Encourage Require new developments to establish buffers from streams to limit pollution from pesticides and nutrients.~~
 - x. Design landscapes to be drought- and pest-tolerant.
 - xi. Promote opportunities to recover and utilize wastewater.
 - xii. Encourage the use of reclaimed wastewater for agriculture and landscape irrigation supply water. Encourage dual ~~Dual~~ plumbing that allows graywater from showers, sinks and washers to be reused for irrigation ~~should be included~~ in the infrastructure of new developments.
- j. Continue educational programs on water quality and water resources.
- k. Integrate watershed plans with county planning and programs.

19. How should septic systems and package sewage treatment plants be regulated to support water quality?

- a. Support on-going efforts of the Butte County Public Health Department to update on-site wastewater policies and standards.
- b. Allow case-by-case assessments of septic and other wastewater treatment systems to determine appropriate system designs and

densities and allow consideration of new technologies supported by State and County practices.

- ~~e. Establish a program to monitor runoff into Paradise and Magalia Reservoirs.~~
- ~~d. Manage wastewater treatment (similar to the Town of Paradise) in high density and sensitive areas where a sewer system is not feasible.~~
- ~~e. Conduct education and outreach to homeowners about wastewater and its impacts on water quality.~~

20. How should the County minimize flood hazards?

- a. ~~Plan~~Discourage development in areas mapped by FEMA as within the ~~100-year~~ flood plain to appropriately address flood issues.
- ~~b. Establish a “no net fill” policy to prevent a reduction in flood capacity in areas mapped by FEMA as within the 100-year flood plain.~~
- ~~c. Require any development within FEMA’s mapped 100-year flood plain to be elevated above projected flood water elevations.~~
- b. Support and seek funding for~~fund~~ studies of levee stability throughout the county for the levees the State owns~~County~~.
- c. Continue to seek funding to stabilize the Magalia Dam.
- d. Develop a plan and seek funding to address stormwater management ~~Address flood control~~ problems in the Keefer Slough/Rock Creek area.
- e. Protect~~Ensure protection of~~ existing flood control facilities.
- f. Maintain watershed health.
- g. Manage watersheds to minimize flooding.

Economic Development

21. How should the County seek to improve the local economy, attract higher wage jobs, and improve its fiscal health?

- a. Create a bold, powerful, forward-looking countywide Economic Development Strategy that identifies key sectors and lands for business expansion in the county and programs to achieve that expansion. This strategy ~~may~~shall include the following:
 - i. Create a County-level economic development function.
 - ii. Partner with educational institutions and businesses to develop flexible Research & Development and incubator space in the county.
 - iii. Develop programs to retain ~~all of~~ Butte County's college graduates as county residents and employees.
 - iv. Develop programs to recruit new, high-quality workers to Butte County.
 - v. Provide fiscal incentives, such as tax exemptions, to attract new industry.
 - vi. Provide additional support for local Chambers of Commerce and organizations that support small businesses.
 - vii. Promote local tourism and visitor-oriented recreation through more aggressive marketing programs (see question 22).
 - viii. Support existing and seek to attract new manufacturing, commercial and office uses (see question 23).
 - ix. Promote the agricultural sector through adoption of various policies (see question 16).
 - x. Promote sustainable business and the development of new economic opportunities related to renewable energy.
 - xi. Utilize existing ~~Conduct a~~ workforce studies.

- b. Prioritize projects through permit streamlining in those areas where ~~study to determine whether~~ the County receives above-average property tax share (relative to property tax shares that the County receives elsewhere in the unincorporated area).
- c. Require concurrency of development in mixed-use developments so that revenue-generating non-residential uses do not appreciably lag residential development.
- d. Subject large developments that may not be served at adequate levels (e.g., staffing, equipment and facilities) by existing public services to a requirement to undergo “Planned Development” review before gaining full entitlements to develop. As part of such approval, require preparation of a fiscal impact analysis (in addition to a public facilities financing plan, as described in Policy (e) below) and any required mitigation measures, to ensure that the County will be able to maintain adequate service levels and ensure fiscal sustainability.
- e. Through the “Planned Development” review process, ensure that new developments that will not be adequately served by existing infrastructure and facilities and/or through the adopted countywide impact fee program prepare a public facilities financing plan, which identifies the needed public improvements and establishes a plan to pay for and develop the required public improvements.
- f. When it is to the County’s advantage, negotiate development agreements with sponsors of projects requiring discretionary approvals, to ensure that the County’s interests will be protected. Terms of development agreements need to be negotiated on a case-by-case basis, considering the potential costs and benefits to the County from a given development along with the project’s ability to shoulder the requirements of the agreement and remain financially feasible and competitive in the marketplace. All development agreements should include sunset provisions.
- g. Where development is more appropriate to occur via annexation to a municipality, negotiate revenue sharing agreements, either

- on a master revenue sharing agreement basis or on a case-by-case basis, to ensure that if municipalities annex unincorporated areas, the County will have access to adequate revenues to maintain countywide services that will extend to new development in the municipalities.
- h. Prepare an updated capital improvement plan that identifies the new public facilities that will be needed in order to maintain the desired service levels through General Plan buildout.
 - i. Use the updated capital improvement plan along with the new general plan development assumptions to develop an updated development impact fee program, to ensure that new development pays its fair share of public improvement costs for countywide infrastructure and facilities.
 - j. Should it be desirable to charge fees that are less than what is necessary to completely fund new development's share of projected countywide costs (e.g., for economic development purposes), identify and allocate adequate funds from other sources to make the impact fee program whole.
 - k. Utilize developer agreements as a tool to implement public facilities financing plans and to secure various benefits from significant new development projects.
 - l. Pursue agreements with the municipalities of Butte County whereby the municipalities would collect impact fees on the County's behalf from new development in their jurisdiction that would generate demand for County public facilities. At a minimum, incorporate such agreements into new annexation proceedings but seek a blanket agreement that covers all new development within municipalities that would generate demand for County services.
 - m. Review the County's current practice of setting aside a portion of General Fund monies each year in order to fund existing development's share of new public facilities costs (i.e., that portion that cannot be charged to a development impact fee program) and determine if set-asides are adequate. If current set-

asides are not adequate, seek to increase set-asides accordingly or to develop other sources of revenues to generate funds.

- n. Where County redevelopment project areas generate tax increment funds, strategically use these funds to pay for existing development's share of public improvement costs when other financing options do not exist.
- o. Pursue grant funds to help pay for existing development's share of new public improvement costs.
- p. Consider formation of Redevelopment Project Areas or Infrastructure Financing Districts where such mechanisms can provide financing tools to help pay for existing development's share of new public improvement costs.
- q. Initiate talks on a countywide basis to have municipalities collaborate with the County to generate funds to help pay for the share of County public improvement costs that are attributable to existing development within the municipalities. This could include exploring such mechanisms as the municipalities agreeing to set aside a portion of annual revenues to help pay for existing development's share, or the municipalities collaborating with the County to promote and gain voter approval for a countywide measure that would generate needed funds.

b. Other _____

 - v. Guidelines for engagement with local Indian tribes to create a confidential cultural resources inventory of the county and development of a reliable and trustworthy system and relationship between local tribes and the County to protect confidential tribal information.

- vi. Re-evaluation of sites of past archaeological investigations that may be impacted by proposed development to assess cultural sensitivity, using state-of-the-art methods.
- vii. Recognition of the importance to Native Americans of natural resources, including oak woodlands, deer herds, water bodies and riparian corridors, as well as aquatic, riparian and upland plant and animal species. Recognition of the importance to local Native American tribes of gathering and use sites, as well as other traditional tribal cultural places. Consideration of the use of these resources and sites by contemporary Native Americans in planning for land use, development and management. Consultation and other coordination with local Native American tribes to preserve these habitats, resources, sites and species.
- viii. Establishment of protection measures to acknowledge and protect traditional tribal cultural knowledge and intellectual property rights.

~~Note: At the November 14, 2008 Planning Commission Study Session, the Planning Commission did not provide specific guidance on the suggestion to implement a historic properties management plan, as suggested by the Butte County Cultural Resources Coalition. However, the policies provided below, which were all supported by the Planning Commission, could be incorporated into a historic properties management plan.~~

- a. Seek to protect significant archaeological and historical resources.

Examples of such landscapes include rock walls, barns, silos, agricultural land use patterns, grange halls and historic farmhouses, as well as linear features such as historic roads, emigrant and Native American trails, flumes, ditches and historic highways. Other examples include citrus colony land use patterns such as those in Palermo and Durham.~~
